This information is collected for enrolment application purposes, additional information will need to be collected from you by the Kindergarten at a later date.

1. To be able to attend Kindergarten your child must turn 3 years old on or before April 30 in the year of attendance and will need to be 3 years of age before commencing. This is the minimum age requirement in Victoria.
2. For help filling out this form, contact LMPA – Kindergarten Central Enrolments on 5443 1229 9:00am to 5:00pm weekdays.
3. Families will be required to complete a new 3 Year Old or 4 Year Old Kindergarten Enrolment Application each year.
4. Applications for the first round of placement offers need to be lodged by **JUNE 15, 2021**.
5. Incomplete applications will not be processed. Please ensure all documents are provided with your application e.g. Application fee, Health Care/Pension Card and Australian Childhood Immunisation Register (ACIR).
6. Families have 10 days to respond and return their letter of offer.
7. Please inform LMPA – Kindergarten Central Enrolments if for any reason you will not be able to receive the letter of offer or your details have changed.
8. If you are sending your form by mail it is recommended that you use Registered or Express Post.
9. It is your responsibility to ensure that this application is received by LMPA - Kindergarten Central Enrolments.
